Battle Creek River Watershed Planning Project

July 2002 through December 2004

Stakeholders concerned about the water quality of the Battle Creek River Watershed initiated the Battle Creek River Watershed Planning Project in the spring of 2000. The Battle Creek River is one of the leading contributors of sediment and phosphorus to the Kalamazoo River. The watershed is primarily rural and encompasses 187,000 acres in northern Calhoun, southeastern Barry, and southern Eaton counties of southwest Michigan. It is also one of the flashiest gauged tributaries in the Kalamazoo River Watershed. Through a rigorous inventory of the watershed, the main source of sediment was found to be stream bank erosion resulting from historic dredging. Berms created from the widening, deepening, and straightening of the channel have disconnected the river from its floodplain. An extensive geomorphic assessment is being conducted to determine the river's stability to help determine appropriate management methods and options. This project resulted in the development of a watershed management plan for the Battle Creek River watershed.




Project Highlights:

- ★ 5 acres of the riparian corridor
 were donated to the Calhoun
 Conservation District and 22 more acres within
 the watershed are in the process of being
 donated
- A long-term geomorphic assessment study is being conducted on the Battle Creek River to determine stream stability, and stream bank and bed erosion
- Two dam removal projects are in the works with other sources of grant dollars in the amount of \$150,000,00
- A Natural Resources Inventory was conducted for Pennfield Township
- Approval of the Battle Creek River Watershed Management Plan by MDEQ to EPA standards

- 30,000 newsletters distributed throughout the

- A ten-day canoeing expedition down the Kalamazoo River from Albion to Lake Michigan (Kanoe the Kazoo) was held in the summer of 2003. Over 3,000 people participated in the event, and over 60 canoed down the Battle Creek River for one of the days
